For and on behalf of the Midnapore Kharagpur Development Authority, the Executive Officer, Midnapore Kharagpur Development Authority, invites sealed percentage rate tenders for each of the following works by two cover system. Pre-qualification documents in a separate cover and Bid document with schedule rate in another cover are to be submitted by the qualified contactors viz. Contractors registered in appropriate class with PWD/MKDA and bonafide Govt. outsiders who satisfy the terms and conditions set out in pre-qualification document.

Intending bidders may download tender documents from e-procurement portal of Govt. website www.wbtenders.gov.in. The pre-qualification and bid documents duly filled in all respect should be submitted on-line through our e-portal. Midnapore Kharagpur Development Authority does not take any responsibility for the delay caused due to non-availability of Internet connection or traffic jam etc. for on-line bids.

The amount of Earnest Money & Bid Document should be deposited separately, by Net Banking (any listed bank) through ICICI Bank Payment Gateway, valid for 180 (one hundred and eighty) days shall be required to be submitted by each Bidder ("Bid Security") or, On selection of RTGS/NEFT as the payment mode, the e-Procurement portal will show a pre-filled challan having he details to process RTGS/NEFT transaction. The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his Bank account. Payment made otherwise, will be rejected.

The pre-qualification documents alone will be opened by the Executive Officer, Midnapore Kharagpur Development Authority in presence of bidders.

The financial bid document of the technically qualified bidders will be opened for evaluation and selection of qualified bidders will be declared after Technical evolution and the other bid documents will be unopened. No separate intimation will be given for this, unless the above date is changed .In case of change of date, due intimation will be given in News dailies. No individual intimation will be given. Name of the qualified bidders will be displayed **in the office notice board.**

The Executive Officer, Midnapore Kharagpur Development Authority reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.

The eligibility criteria are given below :

Achieved in any one year during last five years in the same name and style (excluding current year) a minimum financial turnover and at least 50% of which is from civil engineering construction works) equivalent to amount given below -

- The turnover will be indexed at the rate of interest 8% for a completed financial year.
- The applicant in the same name and style as prime contractor should have successfully completed at least one contract value of same type of work at least 40% for 1st Call, 30% for 2nd Call & 20% for 3rd Call of the proposed contract within the last 5 years.
- Income Tax return should be submitted for last 5 years.
- Sales Tax & Professional Tax clearance certificate.
- Pan Card & GST Registration Certificate should be furnished (Scan Copy).
- For Additional Performance Security Govt. of West Bengal PWD Go No. IT-06/2017/444-R/PL Dt. 18-04-2017 will be followed.
- The security deposit will be repaid to the agency (contractor) after 5(five) years for bituminous work & concrete road work, 3(three) years for bituminous repairing work & concrete road repairing work, 1(One) year for building, culvert, drain & bridge etc and 5(five) years for Electrical works of satisfactory completion of the whole work, in case of failure to complete the work within the stipulated time or in any case of failure to rectify and defect arising during the security period penal measure will be taken and the security deposit will be forfeited and the contractor will be black listed.

To qualify for a Package of contracts made up of this and other contracts for which bids are invited in the NIT, the bidder must demonstrate having experience and resources sufficient to meet the aggregates of the qualifying criteria for individual contracts.

The amount of earnest money is 2% of the estimated cost of this work.

All duties, taxes, royalties, Cess, [including 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. **1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare Cess Act, 1996 will be deducted from the running bills.**

The intending bidders are requested to inspect the alignment of the proposed site before quoting their rates.
