Notice for selection of Members of Child Welfare Committee

Applications are invited from eligible candidates for serving as **Member of Child welfare Committee**, constituted under the Juvenile Justice (Care & protection of Children) Act, 2015 in the different districts of the state of West Bengal as detailed below. Those who satisfy all eligibility criterion as on date **01.01.2022** will also be allowed to participate in the interview.

Important Information

- Name of the position** : **Member, Child Welfare Committee**
- No of Vacancies** : 4(four) for the post of **Member, CWC** in each District (at least one shall be woman)
- Allowances** : The members of the committee shall be paid such seating allowance, travel allowance and any other allowance as the state Govt. may prescribe but not less than Rs 1500/- per seating.
- Age (as on 01.01.2021)** : Shall be above 35 years and not above 67 years
- Essential qualification** : Shall have a minimum seven years of experience of working with children in the field of education, health, or welfare activities

OR

Should be a practising professional with a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or in the field of law

OR

Should be retired legal or judicial officer.

All the qualification and experience must be completed on or before 01.01.2022

General information for applicants:

- The term of member of child Welfare Committee shall not be more than for a period of 3 (three) years from the date of appointment.
- The Member of the Committee shall be eligible for appointment of maximum of 2 (two) terms.
- Scope of work: The Committee shall sit on all working days for a minimum of six hours commensurate with the working of a magistrate Court, And for at least 20 days in a month.
- Residence: the candidate must be a resident of the district for which he /she is an applicant.
- A member selected by the Selection Committee should not
 - i) Beholding such full-time occupation that may not allow the person to give necessary time and attention to the work of the Board or the Committee.
 - ii) Be associated with any Child Care institute, directly or indirectly, during his/her tenure as a member of the Board or Committee or have any other conflict of interest.
 - iii) Hold an any office in any political party during his/ her tenure, or
 - iv) Be insolvent.
- A member shall be eligible for appointment of maximum two terms.
- For additional information, candidates may refer to the Juvenile Justice (Care and Protection of Children) Act, 2015 along with the West Bengal Juvenile Justice (Care and Protection of Children) Rule, 2017.

The willing candidates may apply in the prescribed application format through **ONLINE Portal Only** in the website <http://wbcdwds.gov.in> from **27.06.2022**. **In any case application will not be received by hand or by post or through email.**

Last Date for submission of application: 6 PM of 27.7.2022. The portal will be closed at 6 PM of 27.07.2022.
