

Sub: Contractual engagement of retired Govt. employees in the post of Assistant Accountant of Mid Day Meal Section in different Blocks/Municipality under Paschim Medinipur District.

In pursuance of order of the School Education Department, Appointment Branch, Bikash Bhaban, Govt. of West Bengal vide No.314-SE(Apptt.)/10M-05/07 dt.31.03.2008, the persons as detailed below are hereby engaged on contractual basis to work as Assistant Accountant for a maximum period ending on 31.12.2020. Their places of posting are mentioned below against their names. They will get remuneration of Rs. 11,000.00 (Rupees Eleven thousand) only for Assistant Accountant per month from the date of joining as per terms and conditions mentioned below. He is directed to join his place of posting on **02.01.2020** without fail. If he fails to join his appointment will be treated as cancelled. They are requested to submit their bank A/C details to the Bill Clerk, Mid Day Meal Section for payment of their remuneration after joining.

- The contractual engagement will take effect from the date of engagement mentioned in the engagement letter (Provided you join in the post on that day) and will continue till one year or till further Govt. Order whichever is less.
- Assistant Accountant engaged on contractual basis, you will have to discharge the duties and responsibilities of the Assistant Accountant as laid down and such other works as may be assigned by your superior/ controlling authority from time to time.
- For the purpose of the works mentioned above, this engagement will not be treated as employment / re-employment / commercial employment. For the above mentioned work, a consolidated amount of Rs. 11,000.00 (Rupees Eleven thousand) only for Assistant Accountant per month is payable.
- The appointing Authority will have full liberty of placement or posting.
- No increment /allowance /bonus /ex-gratia except the above mentioned amount shall be payable to you for your services.
- He will have the right to leave his contractual engagement after giving 15 days notice in writing. Similarly, his engagement is terminable, at the discretion of the authority, at any point of time, by giving him 15 days notice in writing.
