The pre-qualification documents alone will be opened on **06-06-2018 (Wednesday) at 15-00 Hours** by the Addl. District Magistrate (Dev.), Paschim Medinipur in presence of bidders.

The financial bid document of the technically qualified bidders will be opened for evaluation and selection of qualified bidders will be declared after Technical evolution and the other bid documents will be unopened. No separate intimation will be given for this, unless the above date is changed .In case of change of date, due intimation will be given in News dailies. No individual intimation will be given. Name of the qualified bidders will be displayed in the office notice board.

The Addl. District Magistrate (Dev.), Paschim Medinipur reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.

The eligibility criteria are given below: -

Achieved in any one year during last five years in the same name and style (excluding current year) a minimum financial turnover and at least 50% of which is from civil engineering construction works) equivalent to amount given below -

- The turnover will be indexed at the rate of interest 8% for a completed financial year.
- The applicant in the same name and style as prime contractor should have successfully completed at least one contract of same type of work at least one-third value of the proposed contract within the last 5 years.
- Income Tax return should be submitted for last 3 years.
- Sales Tax & Professional Tax clearance certificate & Pan Card (Xerox copy) should be furnished (Scan Copy).

To qualify for a Package of contracts made up of this and other contracts for which bids are invited in the NIT, the bidder must demonstrate having experience and resources sufficient to meet the aggregates of the qualifying criteria for individual contracts.

The amount of earnest money is 2% of the estimated cost for **“Construction of Car Parking Shed in the Collectorate Compound of the District Magistrate, Paschim Medinipur.”**

All duties, taxes, royalties, Cess, [including 12% GST & 1% Cess under W.B.
