

Terms & Conditions

- 1) The contractual engagement will take effect from the date of engagement mentioned in the engagement letter (provided you join in the post on that day) and will continue till one year or till further as per Govt. order whichever is less.
- 2) Group 'C' employees (Clerical posts) engaged on contractual basis will have to discharge the duties and responsibilities of the Group 'C' employees as laid down and as may be earmarked by the superior Authority.
- 3) For the purpose of the works mentioned above, this engagement will not be treated as employment/re-employment/commercial employment. For the above mentioned work, a consolidated amount of Rs. 10000/- (Rupees Ten Thousand) only per Month will be paid.
- 4) The Appointing Authority will have full liberty for placement or posting.
- 5) No increment/Allowance/Bonus, ex-gratia except the above mentioned amount shall be payable to him for such service.

- 6) The candidate will have the right to leave such contractual engagement after giving 15 days Notice in writing. Similarly, his engagement is terminable at the discretion of the Authority at any point of time by giving him 15 days notice in writing.


