For and on behalf of MKDA (A statutory body of Government of West Bengal), the Executive Officer MKDA invites sealed quotations / bid from the eligible, bonafide & reputed contractors / agencies who are willing to **Construction & Installation of Hoarding Structures and Advertisement at the following locations within the Jurisdiction area of MKDA** which will be received by E.O., MKDA up to 3:00 pm of 01-10-2020 through postal / courier or by hand and will be opened on the same day at 4:00 pm.

Terms and conditions of the following works:

- The steel frame of the high elevated hoarding at the above locations should be proper sections and size and good quality and shall be capable of wear and tear against natural climate and calamities such as storms, pressure of wind and rain etc. and the structural design should be beautiful. Design of structure will have to be produced with the quotations.
- Before agreement Design of structure should be vetted by the selected agency from any reputed structural engineer.
- Entire cost of such construction and installation will have to be borne by the selected agency.
- An agreement will be made by this MKDA with the selected agency for using the same for 5 years. During this period of 5 years the agency can use the same for advertisement purpose for which a considerable amount will have to be paid to MKDA. This amount is to be quoted by the agency. After expiry of this contact period the renewal of contract may be done if the authority desires.
- Cost of Participation Fee is 2000/- (Non-refundable). The amount of Participation Fee should be deposited in favour of "E- Procurement of MKDA" at UBI Bank A/c No – 0788012026613 (IFSC Code No:UTBIOSPC34), specifying the name of tenderer and NIQ Number in the Paying Slip through RTGS / NEFT / CBS System / Directly deposit on account only. Payment made otherwise will be rejected.
- The payment of contract amount will have to be paid in advance by the selected agency and at the beginning of 5 years contract and before issuing work order.

- G. Necessary Electric connections are to be obtained in the name of selected agency from the appropriate authorities.
- H. The agency is to keep the Gantries and posts clean thoroughly so that no public complaint is received at any time.
- I. The agency is to undertake minor repairing of the same as and when required.
- J. This development authority reserves the right to use any or all of these gantries to use for a limited period of time in case of extreme urgency for which no compensation will be paid to the agency.
- K. The subject matter of advertisement must not injure the national integrity, peace and tranquillity among the common people.
- L. Safety and security of the gantry is to be maintained by the agency.
- M. For any casualty caused due to the latches of the agency the MKDA will not be responsible.
- N. It is clearly pointed out that if any dispute arises between the agency and sub lessee, the disputed matter will be decided by this development authority and this decision must not be guided by any clause of agreement made among the two parties and this decision will be binding upon the both parties and cannot be challenged before any court of law.
- O. The authorities of MKDA reserve the right to inspect the gantries and posts as and when necessary.
- P. The electric bill charge is to be paid by the selected agency.
- Q. The selected agency is to sign an agreement before starting operation, to follow the above terms & conditions.
- R. Successful bidder will have to execute an agreement with the Executive Officer, MKDA on a Non-Judicial stamped paper of the value of Rs. 100/- (Rupees One hundred) only within the date specified in the letter of intimation. This contract / agreement may be made for a period of one year or any suitable period. After expiry of this contract period the renewal of contract may be done if the authority desires.
- S. Intending agency will have to produce valid certificate of up to date clearance of Income Tax, GST, Professional Tax and labour registration certificate with their application. Self-attested Xerox copies of same shall be produced which will not be returned and original certificates must be produced at the time of open the quotation.


