Successful tenderer will have to execute an agreement with the Executive Officer, MKDA on a Non-Judicial stamped paper of the value of Rs. 100/- (Rupees One hundred ) only within the date specified in the letter of intimation.

**Notes:**


- 1) The tender documents and relevant particulars (if any) may be seen by the intending tendered on all working days during office hours in the office of MKDA at Midnapore.
- 2) Contractors/agencies/suppliers shall have to comply with the provisions of (a) the contract labour (Regulation Abolition) Act, 1970(b) Apprentice Act, 1961(c) Minimum Wages Act, 1948 or the modification thereof any other laws relating the rate and the rule made and other issued there under from time to time.
- 3) Intending tendered should possess a Trade License, PAN Card, Updated P. Tax payment Challan/receipt & Electrical Supervisory License/Certificate (applicable for electrical works only) for being entitled to receive tender documents. Self attested Xerox copies of same shall be produced which will not be returned and original certificates must be produced at the time of application.
- 4) **Earnest money is to be deposited in the form of Call Deposit/ Bank Draft in the name of EO, MKDA & ADM, Paschim Medinipur, Paschim Medinipur Zilla Parishad complex also be enclosed with tender.**
- 5) All materials have to be procured by the contractor from outside and shall have to approve by the Executive Engineer prior to use in the work (applicable for civil & electrical works).
- 6) Cement required for the work will have to be procured by the Contractor through West Bengal Essential Supply Corporation Ltd (applicable for civil works).
- 7) The Contractors/agencies/suppliers are requested to visit the site before quoting rates.
- 8) Authority reserves the right to reject any or all tenders without assigning any reasons and is not bound to accept the lowest tender.
- 9) Work must be completed within specified time period.
- 10) The Earnest money deposited will be released to the un-successful tenderers after 10(ten) days from the date of starting the work.
- 11) If the lowest tenderer fails to executive agreement within the date mentioned in the letter of intimation his name should be brought into book for taking disciplinary action and his earnest money will stand forfeited.
- 12) Royalty clearance certificate is to be submitted by the contractor with each bill for effecting payment (applicable for civil works).
- 13) Each page of tender form, tender schedule, tender notice & other documents if any, must be signed by the tenderer before dropping it.
- 14) In the event of the tender being submitted by a firm, it must be signed separately by each members thereof, or in the event of the absence of any partner; it must be signed on his behalf by a person holding a power of attorney authorizing him to do so.
- 15) The name of the work must be written on the envelope containing the tender.
- 16) This notice inviting tender will be the part of agreement.
- 17) Proportionate quantity of the work is to be done in proportionate time throughout the stipulated time of completion.
- 18) General specification and mode of measurement will be as per of the schedule of Rates of Public works Department, Govt. of West Bengal, w.e.f. 04-07-2001(applicable for civil & electrical works).
- 19) Contractor (tendered) have own or have to arrange Vibratory Roller, Static Roller (8-10 T) capacity, spot Mix Plant, Miller Mixture, Tar Boiler, Bitumen Sprayer, Concrete Mixture Machine, Concrete Vibrator Machine etc. required for the work (applicable for civil works).
- 20) 53 Grade cement, Fe 500 grade steel shall have to be used by the Contractor for the work (applicable for civil works).
- 21) Brand/company /Grade of steel, cement, bitumen to be used for the work shall have to be approved by the Executive Engineer, MKDA, before purchase by the contractor from market, WBECSC & IOC(applicable for civil & electrical works).
- 22) Original cash memos regarding purchase of cement, steel with quantities thereof shall have to be submitted by the contractor along with the bills for effecting payment (applicable for civil & electrical works).
- 23) The value of work as indicated in the price schedule attached with the tender is approximate only and may be increased or decreased appreciably either as a whole or for particular item on the direction of the authority concerned during actual execution. The contract will remain unaffected by such alteration.


- 24) The contractor shall keep a whole time competent and qualified (at least diploma holder) technical representative at work site with intimation to the Executive Engineer, who will receive on behalf of the contractor written instructions through quadruplicate site order book from the Executive Engineer or his authorized representative. The contractor will submit such quadruplicated site order book which will remain under the custody of the SAE in charge of the work. One copy of each order will be handed over to the contractor (applicable for civil & electrical works).
- 25) For Additional Performance Security Govt. of West Bengal PWD Go No. IT-06/2017/444-R/PL Dt. 18-04-2017 will be followed.
- 26) In case of the tender whose tender has been accepted and on executing the agreement, the earnest money deposited by him will automatically be converted into security deposit. 2% of the work order amount will be deducted from the 1<sup>st</sup> RA bill as earnest money and the earnest money deposited along with tender will be released after payment of 1<sup>st</sup>. RA bill. An amount of 8 % of the value of work executed will deducted from each progressive bill starting from 1<sup>st</sup> RA bill (10 % in total) will constitute the security deposit. The security deposit will be repaid to the agency (contractor) after 3(three) months for Repairing of bituminous work of satisfactory completion of the whole work, in case of failure to complete the work within the stipulated time or in any case of failure to rectify and defect arising during the security period penal measure will be taken and the security deposit will be forfeited and the contractor will be black listed .
- 27) If during execution , the contractor is instructed to carry out any item of altered, additional or substituted work not appearing in the priced schedule attached to the tender, the rate for such work will be made on the basis of rates appearing in the schedule of Rates of Public Works ( Roads) Department, Govt. of West Bengal, for Midnapore (NW) operative on and from 04-07-2001 minus/ plus the contractual percentage as applicable and if rates for such item do not appear in the PWD (Roads) schedule, the cost of such works will be determined by the Executive Engineer analyzing on the basis of market rates in the line of PWD (Roads) practice in vague (applicable for civil & electrical works).
- 28) The contractor will store all steel materials, cement and Bitumen purchased by him at site with adequate storage arrangement which will be open to inspection by the Executive Engineer or his representatives (applicable for civil works).
- 29) No claim for escalation of rates will be entertained during the currency of the tender for idle labour or increase in the cost of labour or materials.
- 30) Zilla Parishad/ Midnapore Zilla Parishad means Paschim Medinipur Zilla Parishad and MKDA means Midnapore Kharagpur Development Authority.
- 31) Royalty deduction will be applicable as per rules.
- 32) 1% workers Welfare cess will be deducted from each bill vide No. 34(30)/LS dated 14-09-2006 of Labour Department and FD order No. 853-F dated 01-02-2006.
- 33) Maximum time which will be allowed for execution of scheme will be as noted in item no of the tender notice which should be strictly adhered to by the successful tenderers. A penalty may be imposed as per rules.
- 34) The bidders, who have submitted bids in earlier call for the same work /Road, may revise their quoted rate. In that case they have to resubmit the bids afresh along with cost bidding document and requisite earnest money .Otherwise their earlier bids will be consider along with the bids submitted against this NIT.
