NOTIFICATION

Whereas, in terms of memo no. 549-CS/2021/141-Health dated 15th June, 2021, Govt. of West Bengal, strict containment measures in areas of high incidences of COVID 19 positive cases is found necessary;

And whereas, the State Govt. has issued an order vide no. 753-ISS/2M-22/2020 dated 14.06.2021 under Disaster Management act 2005 read with West Bengal epidemic diseases, COVID 19 regulation 2020 in order to contain spread of COVID 19 pandemic;

And whereas, incidences of COVID 19 positive cases are found to be high in the areas as annexed herewith;


Now, therefore, being the authorized person under the West Bengal epidemic diseases, COVID 19 regulation 2020, I do hereby delineate Broad Based Containment Zones as enclosed in order to close following activities till 4th July, 2021, for the time being, to prevent further spread of the disease;

- a) All offices, Government and Private;
- b) All non-essential activities;
- c) All congregation;
- d) All transportation;
- e) All Marketing/Industrial/Training activities.

Residents of the containment zone shall be exempted and prohibited from attending Government and private offices and their ingress and egress shall be regulated strictly.

Measures in containment zones-COVID 19 as enumerated in Government Orders / Circulars/Advisories issued time to time in this regard shall be in enforced strictly.

This notification will come into force with immediate effect.
