**NOTIFICATION**

Whereas, in terms of memo no. 549-CS/2021/141-Health dated 15<sup>th</sup> June, 2021, Govt. of West Bengal, strict containment measures in areas of high incidences of COVID 19 positive cases is found necessary;

And whereas, the State Govt. has issued an order vide no. 753-ISS/2M-22/2020 dated 14.06.2021 under Disaster Management act 2005 read with West Bengal epidemic diseases, COVID 19 regulation 2020 in order to contain spread of COVID 19 pandemic;

And whereas, incidences of COVID 19 positive cases are found to be high in the areas as annexed herewith;

Now, in continuation of this Office Notification No. 638 / H dated 17/06/2021, being the authorized person under the West Bengal epidemic diseases, COVID 19 regulation 2020, I do hereby delineate Micro Containment Zones, as noted below, in order to close following activities, except Offices of emergency Services, **from 6<sup>th</sup> January, 2021 to 12<sup>th</sup> January, 2021**, for the time being, to prevent further spread of the disease;

- a) All private offices;
- b) All non-essential activities;
- c) All congregation;
- d) All transportation;
- e) All Marketing/Industrial/Training activities.

Govt. offices and vaccination centers shall remain open depending on assessment of nature of works / services required to be maintained by the respective head of offices and with the condition that public access to these offices shall be limited. Identification of officers and staff required to attend offices shall be assessed by the respective head of offices.

Residents of the Micro Containment Zones with the above exceptions shall be exempted and prohibited from attending Government and private offices and their ingress and egress shall be regulated strictly.

Measures in Micro Containment Zones-COVID 19 as enumerated in Government Orders / Circulars/Advisories issued time to time in this regard shall be in enforced strictly.
