TERMS AND CONDITIONS IN CONNECTION WITH PLYING VEHICLE ON DAILY HIRING BASIS FOR THE JUDICIAL OFFICERS AT SADAR COURT, MEDINIPUR, PASCHIM MEDINIPUR TO BE FOLLOEVED BY THE OWNER OF THE VEHICLE.

1. Car must be holding a valid Registration as Commercial canter conforming Bharat Stage-III (latest model) or updated version and diesel driven.
2. Car must be in good and sound condition having road(ALL BENGAL) permit. Tax clearance, PCB certification and all other related documents required for plying on road.
3. The car must be maintained clean by the agency/owner regularly and properly.
4. The owner will be liable to deploy car as and when necessary. Moreover, punctuality shall have to be ensured.
5. The driver of the car should possess the commercial driving license issued by the competent authority or appropriate authority for the class of car he is driving for the period not less than 5 (five) years and should have a running mobile phone. The driver must observe all the etiquette and protocol while performing the duty.
6. No additional payment outside accepted rate is payable for hiring of driver(s) and/or for boarding & lodging of driver(s) /cost for repair etc. arising due to accident met by the vehicle, if any.
7. In case of any temporary withholding of service of the vehicle for repair/maintenance/illness of driver etc. by the vehicle owner, substitute vehicle of same quality and/or, alternate driver is to be provided for the period of withholding subject to prior intimation to the authority concerned.
8. Re-imbusement of POL consumed by the vehicle @1(one) litre HSD for 12 KMs and 1(one) litre lubricant (mobil) for 500KMs will be made separately to the owner as per existing Govt. norms only.
9. Daily rate is implied for 10 working hours each day and additional charge @Rs. 20/- per hour be applicable beyond 10 hours in the same day.
10. Car will be engaged on hired basis subject to renewal of the agreement after certain interval or any further instruction whichever is earlier.
11. The agency has to submit an acceptance letter indicating type of car and rates and all term and conditions levied thereupon.
12. In no case hiring charges will be more than the rate as approved by the Govt. through No.3565-WT/3M-81/98 dt-24-11-2008 of Transport Deptt., Govt. of W.B.
13. The owner of the engaged car will sign an undertaking in N.J. Stamps of Rs.50/- with the user end.
14. The contract deed of the hiring vehicle can be terminated by the District Judge, Paschim Medinipur at any course of time without any prior notice and assigning any further reason thereof.
15. Any sorts of violation of the terms & conditions referred the decision of the competent authority will be the final.
16. The Tender Selection Committee reserves the right to accept any of quoted rate(s) suitable for user and also reserves the right to accept or cancel any or all quotations without assigning any reason thereof.
