- g) No extra Payment on account of the price escalation will be made under any circumstances

**Terms & Conditions**

- Contractors shall have to comply with the provisions of (a) the Contract Labour Regulation Abolition Act, 1973 (b) Apprentice Act, 1961 & (c) Minimum Wages Act 1948 and the modification thereof and other law relating to the rates and the rules made and other issued there under from time to time.
- Up-to-date Income Tax & Sale Tax clearance certificate should be submitted with the tender form.
- Earnest money is to be deposited in the form of Bank Draft in the name of the Secretary, Sri Aurobinda Children's Park-Cum-Zoo Society, Midnapore, Paschim Medinipur.
- The contractor is requested to see the site before quoting rates.**
- Work must be completed within specified time.
- Authority reserves the right to reject any or all tenders without assigning any reasons and is not bound to accept the lowest tender.

At any time of the work, the agreement may be terminated as per discretion of the Sub-Divisional Officer, Medinipur Sadar & Secretary, Sri Aurobinda Children's Park-Cum-Zoo Society, Midnapore in the event of any violation of norms and condition.

- 8) If the lowest tenderer fails to execute agreement within the date mentioned in the letter of intimation, his name should be brought into book for taking disciplinary action and his Security Deposit money will stand forfeited.
- 9) A portion of the bill amount may be deducted in the event of violation of norms & conditions.
- 10) In the event of the tenderer being submitted by a firm it must be signed separately by each members thereof or in the event of the absence of any partner, it must be signed on his behalf by a person holding a power of attorney authorization to do so.
- 11) The name of the work must be written on the envelope containing the tender.
- 12) The accepted Tenderer / Quotationer should arrange for non-judicial Stamp Paper worth Rs. 100/- for agreement before issue of a work order with a Security Deposit amounting to 10 % of the total amount and after successful completion of the work, the Security amount will be refunded.
- 13) Proportionate quantity of the work is to be done in proportionate time through out the stipulated time of completion.
- 14) Royalty clearance certificate is to be submitted by the contractor with each bill for effecting payment.
- 15) Each page of tender form, tender notice & other documents must be signed by the tenderer before dropping it, with full address in the tender form.
- 16) Contractor have own or have to arrange concrete mixture machine, concrete vibrator Machine, etc. required for the work.
- 17) All materials have to be procured by the contractor from outside at his own arrangement.
- 18) All fittings & materials should be approved by the authority before installation.
- 19) Required Water for construction work will be arranged by the contractor.
- 20) The contractor will store all materials i.e. steel materials, cement & other materials purchased by him at site with adequate storage arrangement which will be open to inspection by the authority/Engineer.
- 21) The contractor shall keep a whole time competent and qualified representative at work site with intimation to the Sri Aurobinda Children's Park-cum-Zoo Society, who will receive on behalf of the contractor written instructions through duplicate site order book from the Sri Aurobinda Children's Park-cum-Zoo Society representative/Engineer.
- 22) No claim for escalation of rates will be entertained.
- 23) Labour license to be submitted before final bill.
- 24) TDS / GST etc. as per prevailing norms along with 1% Cess will be deducted from each Progressive & Final Bill.
- 25) The rate should be quoted both in figure and in words; in case of any disparity the rate in words will be final.
