Notice Inviting Expression of Interest

The expression of interest is hereby invited in sealed envelop from the bonafide agencies having experience in running tea/coffee etc. shop for running a coffee/tea etc. stall inside the 'Aurobindo Children's Park-cum-Zoo Society, Medinipur' on monthly rented basis. The following facilities will be given from the authority.

- 1) A room inside the 'Aurobindo Children's Park-cum-Zoo Society, Medinipur' beside the entrance on right side of size approximate 18 feet x 8 feet.
- 2) Plug points as per requirement.
- 3) Tap water.

The tenderer will have to arrange for the item and abide by the conditions: (1) all appliances, lights seating arrangement with large umbrella, micro oven, electric cooker, induction oven etc. (2) Separate electric connection for shop to be arranged by the agency; 'NOC' will be given by the authority (3) No gas/oil burner is allowed (4) Have to pay against the electric consumption on regular basis (5) The food and soft drinks, tea/coffee and snacks have to be sold at market price (6) The wastes are to be disposed off on regular basis at own cost (7) The price list of each item has to be displayed at the front of the shop (8) The items with price which are allowed for selling are to be got vetted from the authority and items not allowed by the authority are not allowed to be kept in the shop and sold (9) The authority may visit the shop at any time and if not satisfied may direct to remove any item or may ask for any action to be taken which are to be complied with then & there by the selected agency during the period of contract (10) No permanent construction attached to the running tea/coffee shop is allowed.

The successful tenderer will have to make a contract with the authority for one year on a non-judicial stamp paper of Rs. 10/- mentioning above terms and conditions and will abide by both the parties. The contract may be renewed for year / year(s) for satisfactory service.

The tenderer will have to deposit Rs. 20,000/- as security money which is refundable without interest at the end of the contract. Any damage to the property of the park or non-payment of electric consumption at any time may be recouped forthwith from the security deposit and the balance amount will be refundable.


The authority has the right to terminate the contact without giving any reasons if.
