

Name of Work:

Comprehensive ONSITE ANNUAL MAINTANANCE CONTRACT of Hardware(18 Computer along with Monitor, UPS and other accessories, 2 Lap-Top, 3 Printer, 2 Projector, 1 24-Port Switch, 1 16-Port Switch, 1 Wifi), Software (OS, Application package, Anti Virus, Driver installation, Garbage cleaning, Data recovery, Data Backup, Restore) Networking (maintenance LAN Setup, urgency basis establish temporary networking in Office and out of Office premises, Wifi / Modem configuration etc) for the District Office of Sarvasiksha Mission.

Technical Terms & Conditions

1. The rate should be quoted both in word & figure for all components, not separately.
2. Up to date Income Tax, Trade License, Professional Tax, GSTN should be submitted.
3. An earnest money of Rs.1,000/- (Rupees One thousand only) payable on Midnapur by account payee Demand Draft in favor of the District Project Officer, Sarva Siksha Mission, Paschim Medinipur should also be submitted.
4. An agreement will be made with the selected tenderer before issuing final work order.
5. Experience on relevant field will get priority.
6. Service call will be made over telephone call / via email and must be attained within 4 hours after reporting.
7. Routine checkup in every week on the above components must be done.

Sealed Tenders should be dropped in Tender Box kept in the office chamber of District Project Officer, SSM, Paschim Medinipur between 11 AM to 3 PM from 26.10.17 to 09.11.17 by the tenderer in person only. Tender Box will be closed after stipulated date & time and tender Box should be opened on 09.11.17 at 3.30 PM in the office chamber of District Project Officer, SSM, Paschim Medinipur.

11. The Authority of Sarva Siksha Mission reserved the right to accept or reject any or all the tenders without assigning any reason whatsoever.


