TERMS AND CONDITIONS

1. The pandels, sheds, stalls barricades, partitions, Welcome gates with related electrical installation, sound light, light system for cultural programme , Public Address system etc. will have to be constructed as per specifications & drawing and the instruction of the Authority/Engineer-in-charge. The quantity of work in the schedule is however approximate and subject to change in accordance with the variation, modification and duration as per need felt by the authority. All materials of approved quality shall have to be used.
2. **Rates are to be quoted for the complete work including carrying, loading, unloading, GST etc. for the entire period (07 days) in all cases no item rate will be accepted.**
3. Railings of the counters are part of the pandels and sheds and are not treated as barricades. All shades must be water leakage/rain proof. Rates also include supplying, fitting, fixing, placing, installation in proper position as per direction and removing the same on the next day of the last duration period is over. Rates shall be quoted including all taxes etc.
4. All works should be ready for handed over to use within 10:00 am on the 22nd November, 2017 positively.
5. The intending tenderer submitting tenders for the works shall have to deposit earnest money along with the tender amounting to Rs.10,000/- through bank draft in favour of The District Magistrate., Paschim Medinipur in any nationalized Bank payable at Midnapore.
6. The successful tenderer shall have to execute an agreement on Non-Judicial stamp paper of Rs.50/- with complete the work as per specifications & quantity within the stipulated time. In case of failure/Non compliance to start the work the security deposit will be forfeited and legal action will be taken against the tenderer.
7. Each tenderer shall have to deposit attested copy of trade license, PAN Card, valid P.Tax (Registration & Clearance Certificate), and I.T. clearance certificate & GST Certificate including requisite credentials on similar type of works with the tender.

10. Sufficient no. of Skilled personnel should remain present during the period of "Sabala Mela'2017" so as to attain emergency situation.
11. The authority reserves the right to accept or reject any or all tenders without assigning any reason there of and/or distribute the works among the tenderers. In case of variation of duration period of the "Sabala Mela'2017" the payment will be made on an average basis.
12. The quantity of works/items may vary as per requirement in the schedule of works and the rate will be finalized with amicable settlement at the present market value.
